## Health Care Providers Receive \$924,000 in Grant Funding to Impact Efficiency, Quality of Care from Cardinal Health Foundation

- 3. Projects that help spread previously successful work.

The Cardinal Health  $E^3$  Grant Program awarded funding of up to \$45,000 per grant to health care providers in 18 states. Since the inception of the  $E^3$  Grant Program in 2008, the Cardinal Health Foundation has awarded just under \$8 million in funding to 284 hospitals, health systems or other health-related organizations across the country.
