Invitation to Improve Community Drug Disposal Programs Through Grant Funding

Additionally, applicants are encouraged to use the comprehensive suite of Generation Rx prescription drug misuse awareness materials as part of their education initiatives. The materials provide parents, teachers, young people, health care professionals and other concerned citizens with unique, interactive resources that teach individuals of all ages about the realities and dangers of misusing prescription medications.
